Accounting and Financial Advisory Firms Step on the Gas

Investment in accounting and financial advisory services remained robust in Q3 2025, reflecting continued confidence in the sector's long-term value. With significant private equity capital now behind many platforms, firms are moving swiftly to acquire and integrate complementary capabilities. The focus has shifted from simply building platforms and consolidating to actively deploying capital to round out gaps in service offerings, deepen specialization, and expand geographic reach. At Clearsight, we are seeing this group emerge as an aggressive buyer category in many of our processes.

- UHY (Summit Partners) acquired Flynn & Company, a CPA firm based in Cincinnati, OH. The acquisition enables UHY to expand its national footprint, enhance client relationships, and bring additional value to businesses in the region

Key drivers include substantial dry powder and fresh capital inflows from institutional investors such as Sovereign Wealth Funds and other unconventional limited partners. However, the era of "easy money" in private equity services has passed. Today, valuation favors assets more focused on operational excellence, value creation, performance improvement, and vertical specialization. 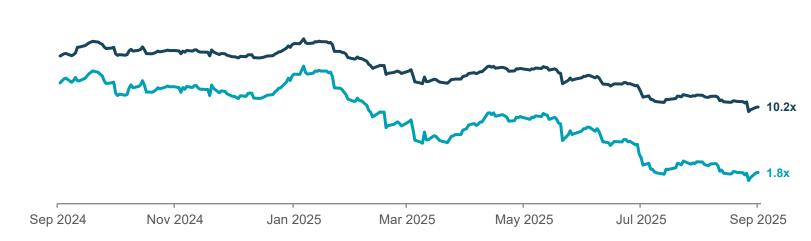

The Business Consulting Index faced increased pressures relative to the market

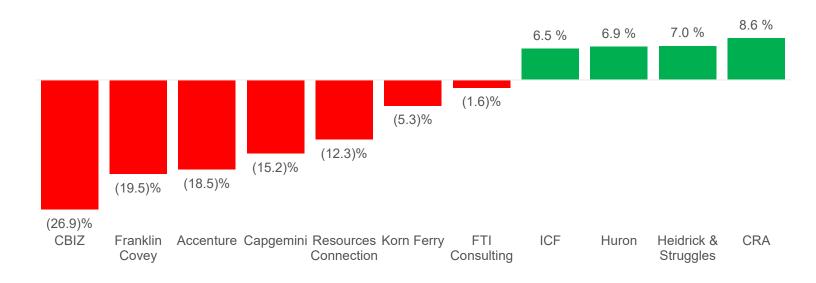
